StreetGames: Hull Active Listening

As part of an exciting partnership, Street Games are working with people across Hull to gather a range of views to better understand how young people in Hull can engage more in Physical Activity.

StreetGames is the leading national charity dedicated to transforming the lives of young people growing up in underserved communities, through the power of sport.

The benefits of Physical activity are well documented and have a profound impact on people's physical and mental health. However, there are also a host of reasons why somebody is inactive. It is important we understand what drives people's current levels of activity so that as a city we can make changes to create a healthier environment for people to be active and reach their potential.

StreetGames role is to engage young people, aged 11 - 18 years old, who are less likely to be physically active to better understand their;

- PERCEPTION of physical activity;

We will do this in creative and diverse ways, working alongside trusted adults and steered by young people.
